PELVIS ELBOWS October 23, 2024: 3 views are provided.

FINDINGS: There is adequate coverage of the femoral heads by the acetabulum. The subchondral bone and articular surface of the coxofemoral joints and stifle joints are normal. No abnormal soft tissue swelling is noted. The pelvis is unremarkable.

The subchondral bone and articular surface of both ankle joints are normal. No degenerative changes are noted. The medial coronoid process is well-defined. There is no evidence of trochlear notch sclerosis. The anconeal process is fused.

CONCLUSIONS: Normal coxofemoral joints and elbow joints.
